## **Medical Director Report:**

- John is out for 1 month.
- Jess is out for 1 week and we have been short staffed this week.
- Cindy and Chloe attended the rural roundtable which focused on developing programming to support the 65+ population. There is a brief that will be shared with the board from the meeting.

## **Operations Director Report:**

- We have hired a new receptionist/medical records position. We also retained Linda at the front desk as we had a position open up.
- Eleanor's last day is October 4<sup>th</sup>. Dr. Tryon is starting October 21<sup>st</sup>.
- We have submitted a self-attestation for the Partnership Health Plan audit.
- Sliding fee scale survey is underway.

## **Executive Director Report:**

- Two pieces of great news this month; We got the \$400,000 from the Huffman community project grant AND we were awarded the Behavioral Health Service Expansion (BHSE) grant for 1.1 million dollars (600K year 1, 500K year 2)!!!! After BHSE ends, \$500,000 will roll into our base grant every year for good.
- We have been working on follow-up items from Kelly's visit. The Master Fee Schedule is currently being reviewed for codes that we don't use and fees will be set up after that and brought to the board for review.
- The annual all-staff retreat took place on September 10<sup>th</sup>. It was a great day. We did a
  mix of team building activities and focused heavily on good working relationships and
  communication.
- I attended rural roundtable in Redding.
- We are working with Larann Henderson, LCSW to develop a scope of service for her
  to support our behavioral health team. With the award of the BHSE grant, she will
  probably take on a bit more of the program set-up.
- Our CFO is beginning audit prep for FY 2023 and the auditor came for an on-site visit on October 1st.
- We are due for a HRSA site visit in 2025 and are starting to prep for that with the Write Choice Network team.
