Board of Directors Meeting, Executive team Summary-March 6, 2025

Medical Director Report:

- We continue seeing multiple cases of influenza A daily as well as other respiratory viruses.
- Dr. Cary Smeltzer was accepted into the UC Irvine addiction medicine fellowship. She
 will have twice monthly webinars and two conferences over the course of the year.
 This is great timing with our push to expand services for substance use
 disorders/treatment.
- Marcelle and I continue working with our subject matter expert through the PHMI grant to improve hypertension and diabetes management. Our current focus is improving and standardizing the workflow of patients with diabetes to our diabetes educator.
- Jess Dawdy, NP, ran a code blue drill with the front desk and medical team and next month will coordinate an ACLS drill.

Operations Director Report:

- We are partnering with the school and MCOE to send us a student intern who wants to go
 into the medical field for the rest of the year (2 hours per day). We will also offer three
 summer intern positions for the AVEd Foundation.
- Staffing: Front desk is fully staffed, training is underway. Offers have been extended to two part-time dentists and a dental assistant. An offer is being prepared for a part-time behavioral health provider.
- Women Infant and Children program (WIC) will be onsite every 2nd Wednesday of the month.
- I am attending multiple webinars on changes in immigrant policy. We trained all staff
 on potential immigration enforcement activities in the health center. Health centers
 are no longer considered sensitive locations and are not exempt from ICE activity.

Executive Director Report:

- UDS reporting was submitted on Feb. 15th. At the last minute, the guidance issued was to withhold Sexual Identity and Gender Identity (SOGI) data. To be discussed.
- ARCH directors have set up a weekly meeting to address ongoing federal funding concerns as well as concerns for Community Health Resources Network (CHRN) funding.
- The Targeted Rate Increase (TRI) was implemented and Partnership is still working out the formula for CHRN. This may have a significant impact on CHRN's continued operation. We may see a reduction in QI revenue if CHRN can't receive our payments anymore, and there may be a payback obligation to CHRN.
- Our audit was presented with no findings.
- We are now having bi-weekly meetings with Kelly Maldonado to advance many of our larger billing projects. We are working on; 1. Automatic Good Faith Estimates 2.
 Presenting billing audit findings to providers 3. Medication charges in ECW. 5. Kelly is working with Jason on coding and templating.
- Our next Operational Site Visit with HRSA will be Oct-Dec 2025. We are on schedule for policy review and the next big item will be the needs assessment, which the Write Choice Network will complete. The risk Management Report will be presented tonight.
